POLICIES AND RULES FOR USE OF THE GREEN

belonging to the First Religious Society (FRS) & Homer Congregational Church (HCC)

The Homer Congregational Church and the First Religious Society in Homer, NY are glad to share our Green. We welcome the use of this beautiful property and offer these rules and policies for the benefit of the entire community:

- The Green may be used by individuals or groups after securing permission from the Board of Trustees of the First Religious Society in the Town of Homer (FRS). Requests may be made through the Homer Congregational Church office.
- Each request will be evaluated individually. FRS reserves the right to refuse use of the property.
- Only one event is permitted at any given time.
- The use of the Green includes use of the bandstand, including the power located on the bandstand and throughout the property.
- A basic donation of \$100, payable in advance to the Homer Congregational Church, is requested. In the event of sub-letting, additional fees will be required.
- A damage deposit may be required. Each event will be evaluated to determine if such deposit is necessary.
- The user agrees to hold harmless the Homer Congregational Church, the First Religious Society, and the Village of Homer. In some cases, proof of insurance may be required.
- Upon completion of your event, the user is responsible for leaving the property in the same condition as it was found.
- No alcoholic beverages are permitted on the Green.
- No smoking or vaping or use of any illicit substance is permitted on the Green.
- Political campaigning/fundraising, solicitation, handing out printed materials or posting signs is not permitted.
- The selling of raffle tickets or other games of chance requires pre-approval, and such activities must be solely for the benefit of the Homer Congregational Church and First Religious Society.

Please note: Our policies may be modified or changed without notice. The FRS operates under the authority of the Board of Trustees of the First Religious Society in the Town of Homer and The Homer Congregational Church.
